# **Objectives**

Measure the quality of the EBC and EC lists as at March 1, 2003.

Assess findings and develop improved strategies, explore combined list.

# **Terminology**

### Quality =

- 1. Coverage (Registered versus Eligibles) and
- 2. Currency (Registered at present address) and
- 3. Accuracy (Voter data entered correctly)

# **Measuring Coverage**

Compared lists to Census 2001 with estimates to March 1, 2003.

Matched voter records and compared the combined list to the March 1, 2003 figures.

# **Measuring Currency**

- Matched data was organized into sets depending on whether the records:
  - matched exactly on both files,
  - matched on voter but not address
  - were unique to one file
- 4,000 records from the sets were randomly sampled.

## The survey approach

3 Steps:

Letters to 4000 voters

- Phone Call to non-respondents
  - Doorstep interviews or registered letters to those not available by phone.






# Results – EBC Coverage




2.11 million voters are registered of an estimated 2.98 million eligible voters.




# Results – EBC Currency



74% of the 2.11 million registered voters have up-to-date addresses






### A combined EBC and EC voters list

- Requires legislation.
- Increases coverage to 2.77 million voters, 93% of all eligible voters.
- Enables shared maintenance activities
- Offers a single voter registration process

### **A Combined List**



EC had not processed the 2003 CCRA address updates by March 1, 2003. These updates would have improved the EC list currency by 8 to 10%.

## **Enumeration in 2004?**

We High Mobility – between 15 - 20% of BC voters will move between May 2004 and May 2005.

A door-to-door enumeration will cost at least \$15 million.

There is a more effective alternative...

## **Enumeration 2004?**

### Recommendations

- Combine lists to increase coverage.
- Work with EC to develop improved maintenance programs.
- Give special attention to under-covered groups such as the young.
- Conduct personal enumeration of the homeless.





### Recommendations for amendments to the Election Act - Fall 2003 session

The intent of the legislative amendments requested for Fall 2003 is to remove the requirement that a general enumeration be conducted in the third calendar year following a general election. With the introduction of fixed election dates, the enumeration of voters in the preceding year is not an efficient use of resources. The ability of the CEO to conduct targeted enumerations as required should be retained, so a focused approach may be taken to addressing under-coverage and address currency problems of certain groups or geographic areas.

The cancellation of the 2004 enumeration will not affect the ability of eligible individuals to vote in the 2005 general election. An expanded pre-election voter registration campaign is planned, which will include a targeted enumeration. Particular attention will be focussed on individuals who may not register through other means. Voters who fail to register or update their registration prior to the election may do so in conjunction with voting, and an expanded "where to vote" card is planned for the 2005 election to assist unregistered voters at that time.

#### Recommendations for amendments to the *Election Act* – Spring 2004 session

The intent of the legislative amendments requested for the Spring 2004 session is to address most of the recommendations in the Report of the Chief Electoral Officer on the 37<sup>th</sup> Provincial General Election, as well as establishing a legislative basis for a long-term, sustainable, and low cost solution to voter registration and voters list maintenance. The recommendations provide the Chief Electoral Officer with the ability to use the federal voters list as a source of new voters and updates to existing voter registrations. Voters on the federal voters list who meet the qualifications to vote in BC would be automatically added to the provincial voters list, eliminating a duplication of effort and facilitating registration by individuals traditionally underrepresented on the voters list. The recommended legislative model is consistent with a trend across Canada of voters list synchronization between federal and provincial electoral administration agencies.

The recommendations also establish that voters who register directly with Elections BC will be required to confirm their eligibility, but no signature will be required at the time of registration. This will facilitate on-line registration and other innovations. All voters will continue to be required to sign a declaration of eligibility at the time of voting, ensuring the integrity of the electoral process is maintained.

The recommendations for amendment include several sections of the *Election Act* in relation to election financing and election administration. The amendments include the recommendations from the CEO report, plus recommendations to amend s. 3 of the *Election Act* to establish a six month implementation period for all amendments, s. 22 to establish that District Registrars of Voters do not have to be public servants, and s. 32 to establish that homeless individuals may use a service provider, such as a soup kitchen or shelter, as their residential address. There are also recommendations to amend several other Acts to limit non-electoral use of the voters list and to ensure that tenants of rental properties and residents of strata properties are permitted to display campaign signs, consistent with the *Canada Elections Act*.

It has been determined that previously-sought amendments regarding juror selection, closure of schools on general voting day, provisional registration of 16 year olds, and resolution of ballot names for two candidates of the same name will not be pursued at this time.






### **Options - Expected Coverage/Currency Results**

## Summary

- Door-to-door enumeration is expensive and no longer effective
- Mail only enumerations tend to only confirm BC voters whose registrations are current
- Recommended approach is synchronized voter registers between Elections Canada and Elections BC supplemented by preelection targeted voter registration
